- **Strengthen Organizational Capacity:** Learn from case studies like the Indianapolis Symphony Orchestra, which increased its annual fund by 50% and secured over 2,000 new donors, to strengthen your organization's capacity and improve donor engagement strategies.
 - **Enhance Community Engagement:** Compare data from regions with high nonprofit employment, such as in St. Louis, MO, where 17% of their 2.8M population are nonprofit employees. This data can inform strategies to build on a community's strong philanthropic mindset, including creating more volunteering opportunities and forming stronger partnerships between nonprofits.
 - **Leverage Successful Campaign Strategies:** Learn from successful campaigns like the Arkansas Children's Foundation, which raised over \$274.9M on its \$250 million goal. Consider applying similar data-driven approaches to prioritize donors and cultivate long-term fundraising relationships at your organization.
- **Optimize Resource Allocation:** Individuals in Memphis, TN give a high percentage of their income to charities (7.13%) compared to other markets. Directing resources towards regions with high charitable giving potential can be an effective use of time and resources for organizations whose reach spans multiple markets.
 - **Utilize Predictive Modeling:** Take inspiration from organizations like Children's Mercy Kansas City, MO, who leveraged predictive modeling to identify new major gift prospects and optimize fundraising efforts. These efforts helped inspire two transformative \$75 million gifts toward their campaign goal.
 - **Inform Planned Giving Strategies:** Use median age demographics to guide planned giving strategies. Cities like Cleveland, OH have older median populations (41.9) compared to other markets and may be more likely to consider planned giving options.

TOTAL NONPROFIT REVENUE



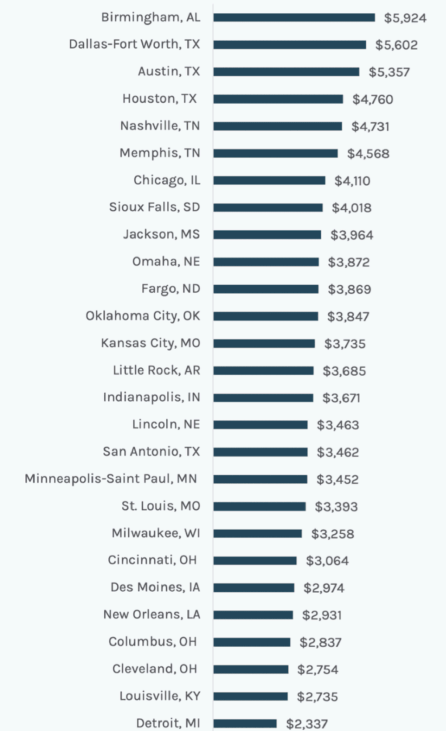
TOTAL CONTRIBUTIONS (\$ Received in Fundraising)

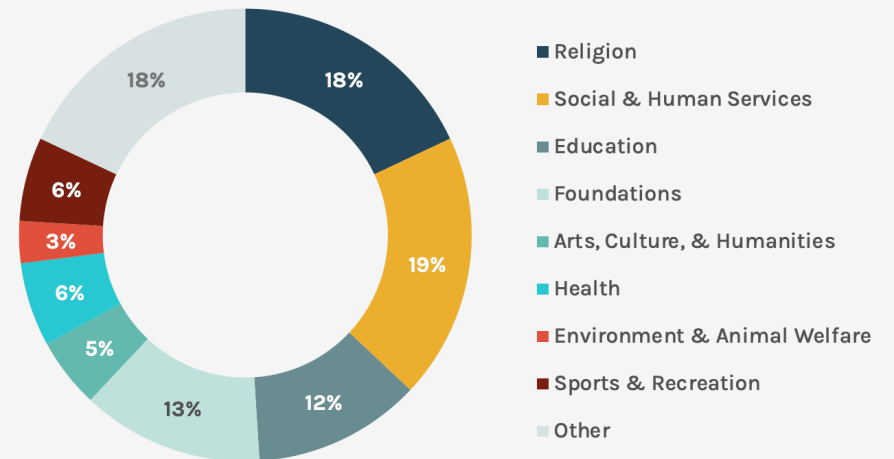

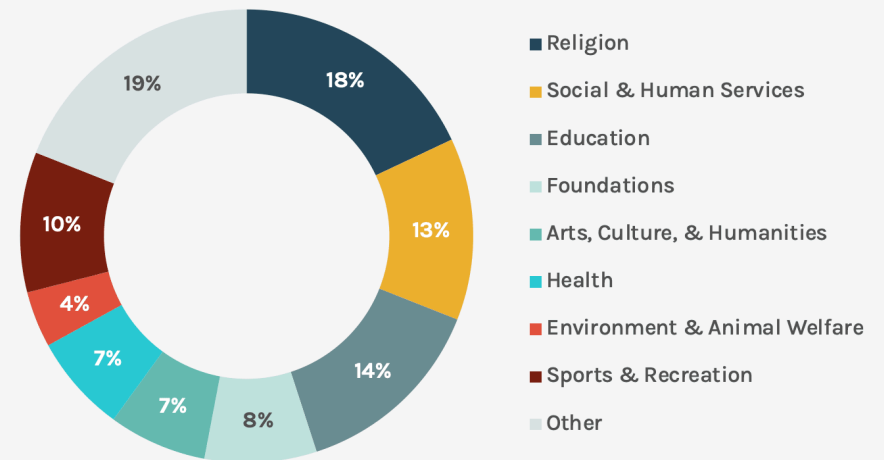

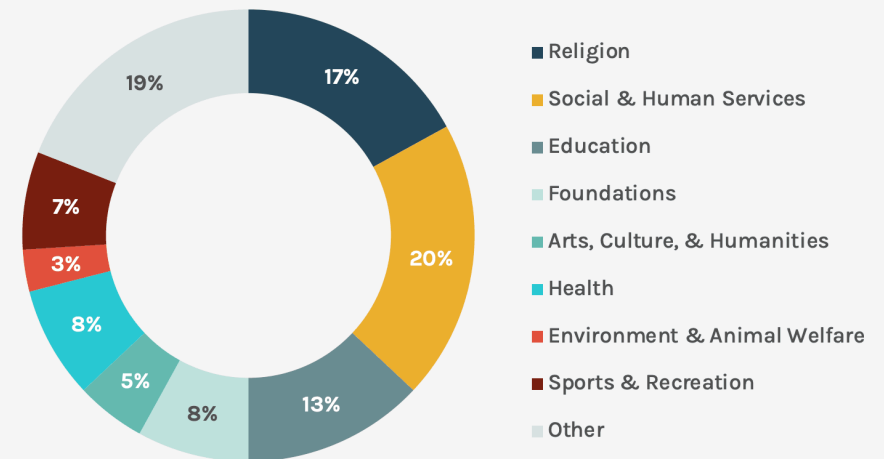

Case Study: Arkansas Children's Foundation

CCS first partnered with Arkansas Children's Foundation to conduct a feasibility study to test the organization's fundraising capacity in the Northwest region of the state and build the blueprint for a capital campaign to construct a new hospital. The *Campaign for a Healthier Tomorrow* has raised more than \$274.9 million on its \$250 million goal. Many of these campaign gifts are the largest received by Arkansas Children's Foundation in its history, including gifts of \$8 million, \$10 million, and \$15 million. CCS's data-driven campaign approach enabled Arkansas Children's Foundation to effectively prioritize the best donors to cultivate for the campaign and long-term fundraising. Our predictive modeling analysis surfaced prospects that went on to give eight six-figure gifts. Prior to the analysis, three of those now six-figure donors had given \$1,500 or less.

As a result of this building campaign, Arkansas Children's Northwest opened in 2018 on a 37-acre campus and now serves as a health and wellness destination for the more than 200,000 children that live in the region. And, the *Campaign for a Healthier Tomorrow* helped realize a vision of providing care close to home in Northwest Arkansas.

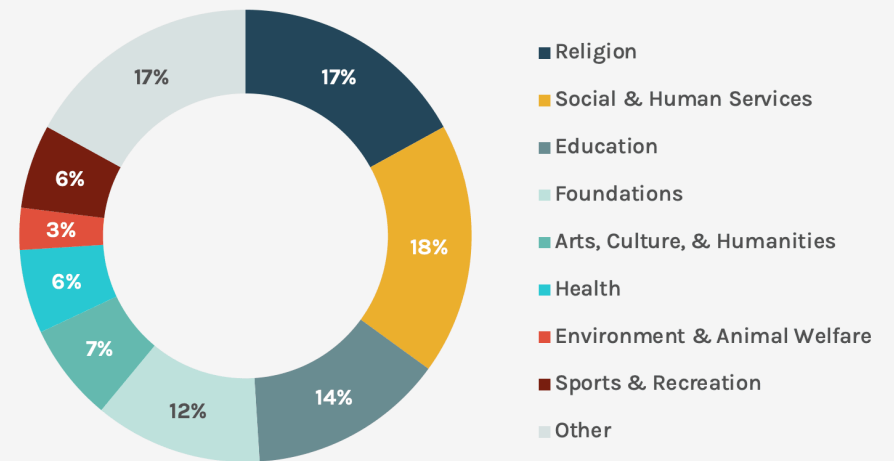

Case Study: Navy Pier

CCS helped advance a bridge campaign with Navy Pier during COVID to further their impact and to expand and diversify their funding sources. This partnership builds on a prior partnership between CCS and Navy Pier.

This critical partnership led to over \$9 million raised philanthropically, inspired a matching public grant of \$8 million from the State of Illinois, and provided momentum for \$9 million from the federal Shuttered Venue Operators Grant program. Throughout the campaign and beyond, Navy Pier was able to explore diverse donor pipelines that paved the way for incredible new community programming.

As a vital leader in the arts and cultural landscape of Chicago and beyond, Navy Pier was proud to reopen and continue to serve as a platform for so many beloved cultural programs and institutions.

B'nai Jehoshua Beth Elohim (BJBE) partnered with CCS for over two years on three projects: the development and implementation of a new membership model, a feasibility study, and a major gift effort focused on reducing the building mortgage.

As with many congregations that we work with across the United States who have implemented this model, BJBE saw an increase in membership, annual fundraising, and overall donor and member satisfaction. In year one, BJBE welcomed 96 new member households and 66% of members increased or maintained their financial commitment from the prior year. Overall, BJBE raised \$1.5 million toward their major gift effort. This shift engaged the community at all levels, from BJBE leadership to new members. Not only are congregants more engaged with the mission of the synagogue, but the culture of philanthropy is broader and deeper than ever before.

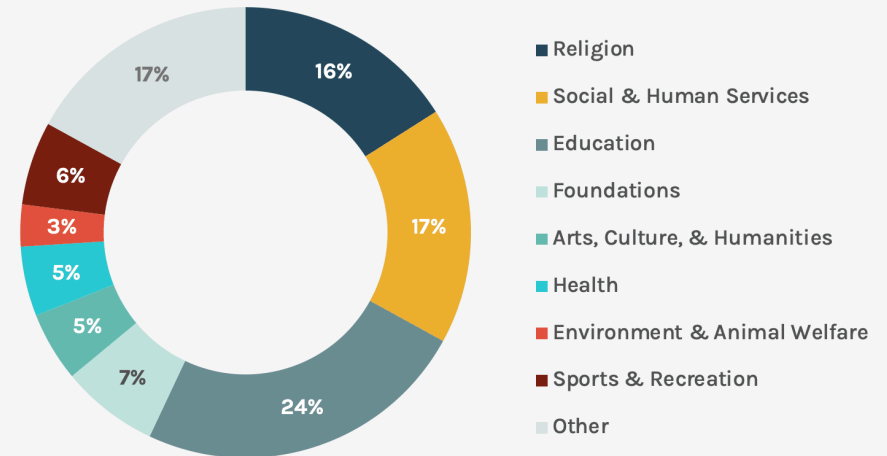

Case Study: Indianapolis Symphony Orchestra

The Indianapolis Symphony Orchestra (ISO) experienced a decline in its endowment and reached a crisis point that threatened the future of the institution. The ISO decided to embark upon its most critical and aggressive fundraising campaign to reengage lapsed symphony donors, find new donors, and increase the awareness of the ISO and its imprint on the community.

While providing interim development services, CCS helped the symphony meet a new donor challenge campaign as well as increase the annual fund by 50%. The thoughtful strategy, messaging, and methodology pursued by the ISO, coupled with the tremendous support from the community, resulted in 2,026 new donors and increased contributed revenue to nearly \$10 million—a record for the ISO.



This extraordinary accomplishment helped the organization restore its credibility with our funding community, and set us up for future fundraising success. CCS helped organize a new systematic approach to fundraising for the development staff and established a new level of engagement, energy, and commitment from the ISO's board of directors.

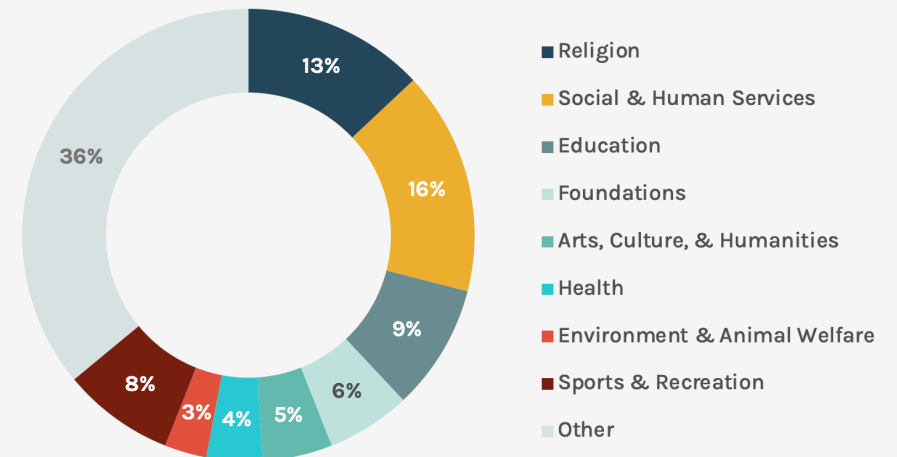

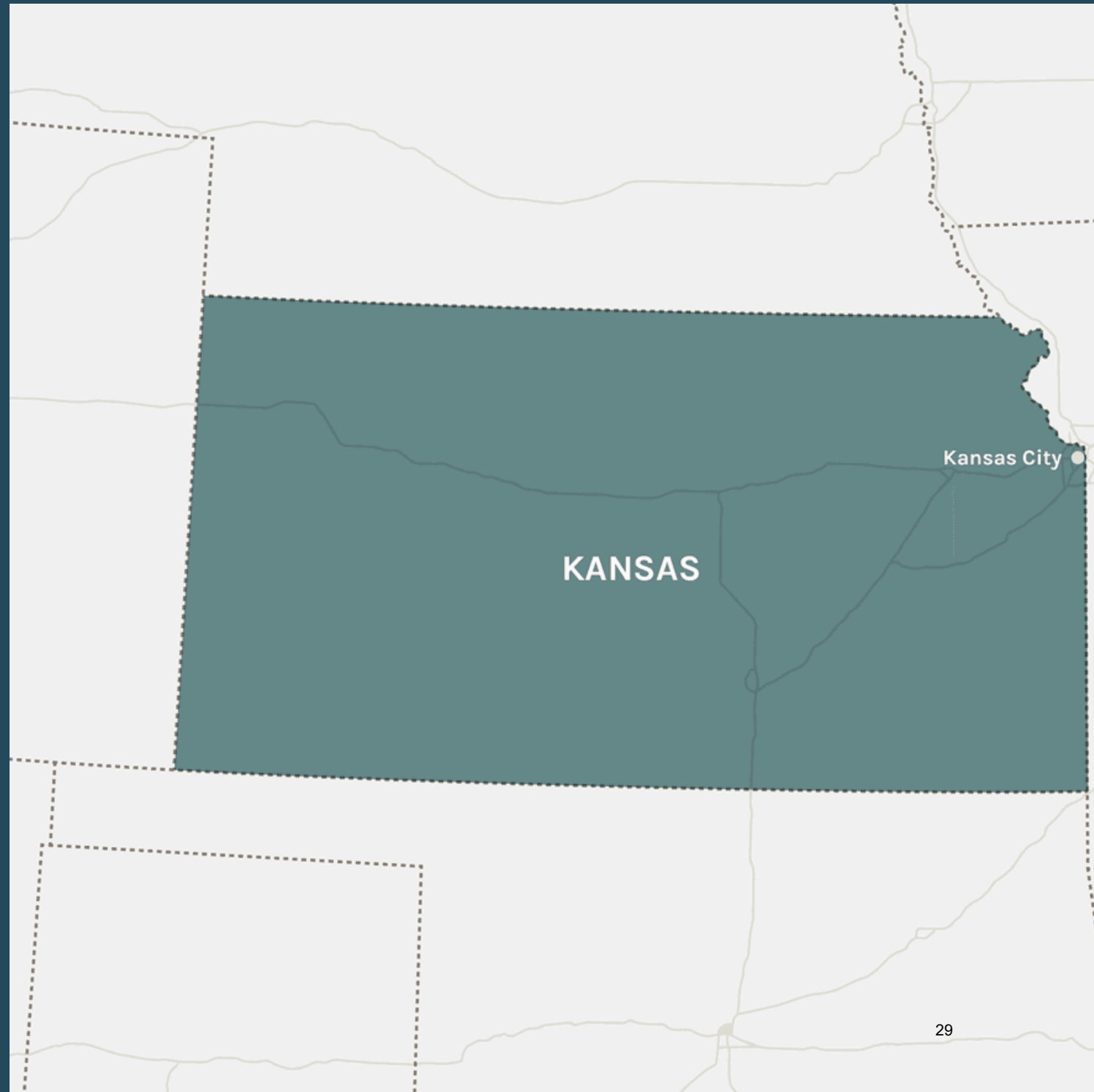
CCS joined forces with Feeding America in 2007 by designing and managing its Campaign Resource Center, with the purpose of supporting the entire 200 food bank network with valuable tools and best practices in the fight to end hunger. Since then, CCS has conducted dozens of capital campaigns, feasibility studies, and development assessments for network members and has worked side-by-side with food bank leaders and volunteers in their communities.

In a three-year period, Feeding America experienced 21% growth in total annual philanthropy and a corresponding dramatic increase in food distribution. Feeding America network members continue to have access to impactful, transformative strategies and best practices, and ongoing support in taking their own fundraising programs to the next level in the fight to end hunger.

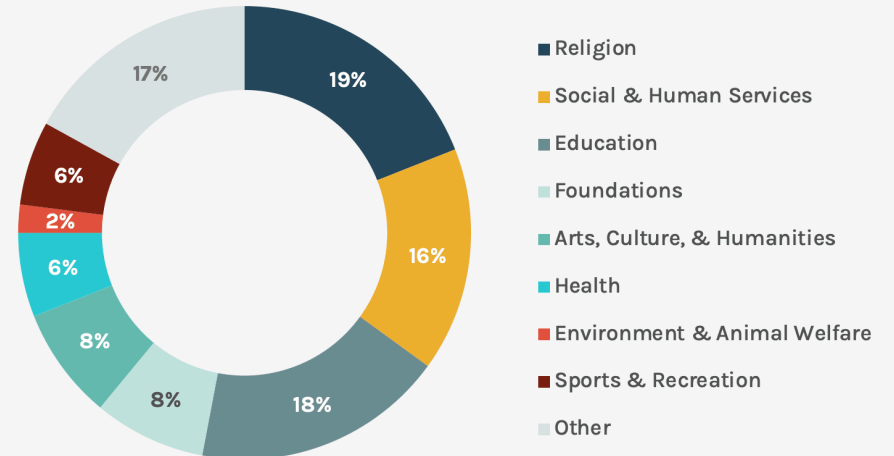

Case Study: Children's Mercy Kansas City

CCS was retained to conduct a feasibility and planning study to determine Children's Mercy's potential to raise as much as \$350 million. Our engagement included an organizational scan to review the philanthropy team's preparedness to undertake this ambitious effort, a predictive modeling exercise to help surface new major gift potential, and more than 100 personal interviews and an electronic survey.

As a result, CCS developed a campaign blueprint to raise funds for the new Children's Mercy Research Institute. Children's Mercy received recommendations on the case and messaging, leadership engagement, prospective donors, and a campaign plan as they launched the campaign in-house. More than \$250 million has been raised to date, including two transformative \$75 million gifts. The construction of the Children's Mercy Research Institute was completed in September 2020.

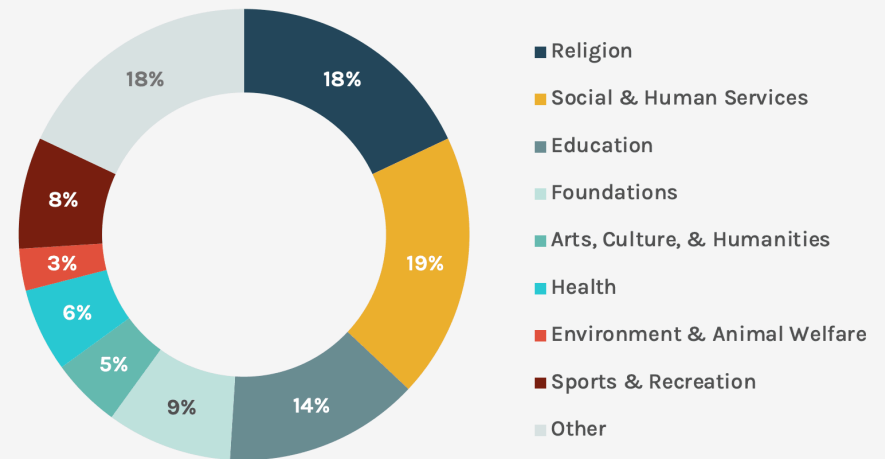

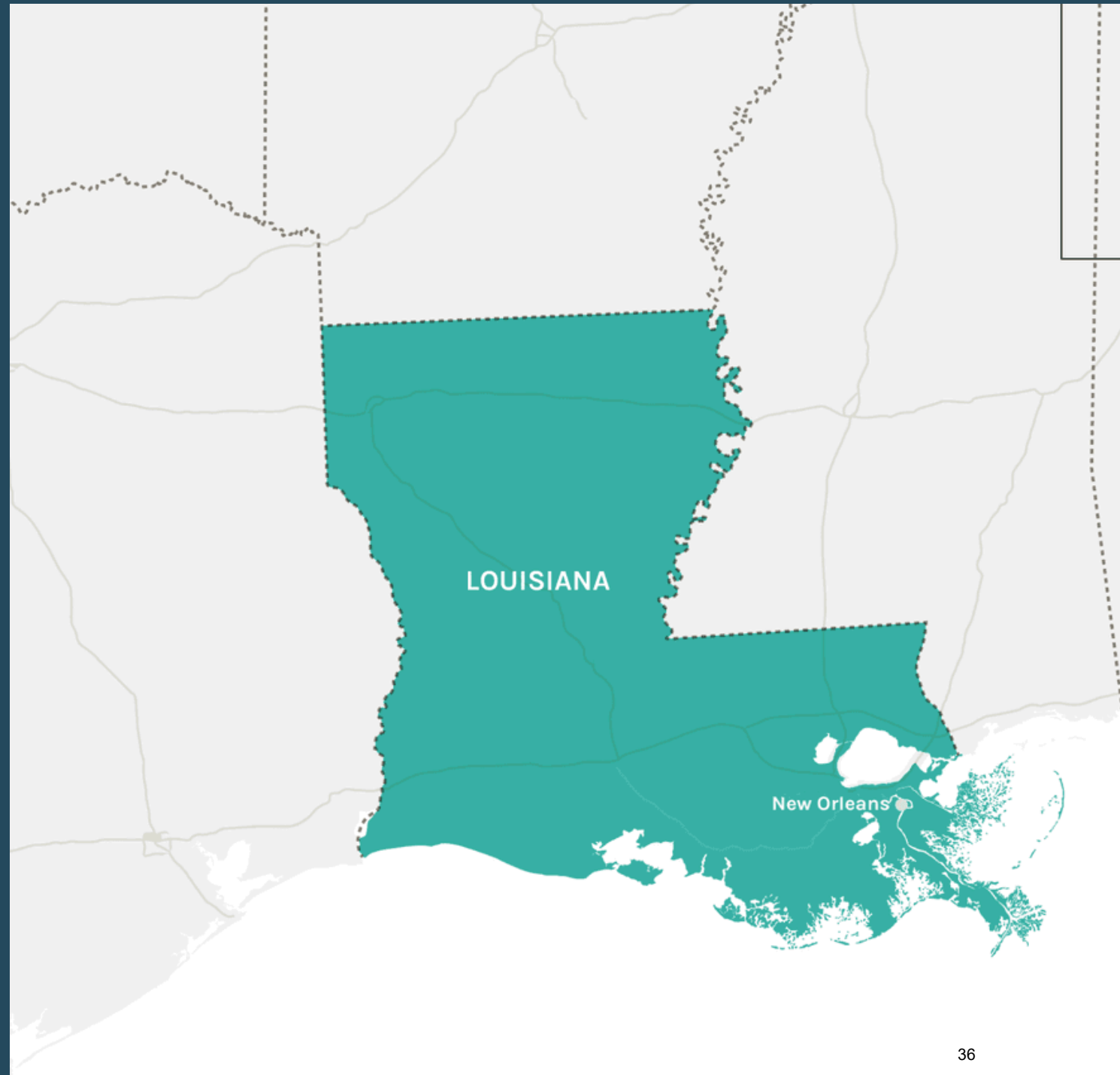
TYPES OF NONPROFITS BY NUMBER OF ORGANIZATIONS

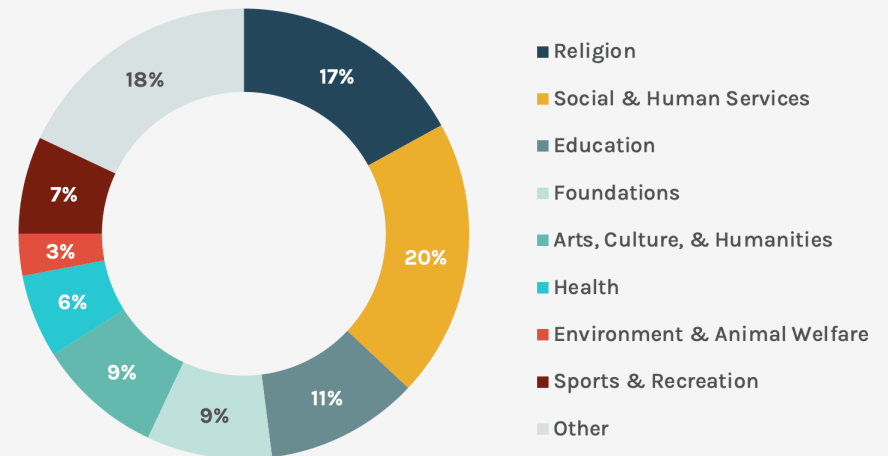

Case Study: University of New Orleans

Throughout our campaign management engagement, University of New Orleans (UNO) secured numerous historic six- and seven-figure gifts to support endowed scholarships, facility upgrades, and areas of greatest need across the campus. When the COVID-19 pandemic hit, UNO never paused, and instead kept moving forward and found unique opportunities to encourage prospective donors to keep supporting the school through virtual meetings and tours.

By the end of CCS's engagement, UNO raised more than \$20 million and was empowered to successfully complete the remainder of the campaign in-house. Through this momentous campaign, UNO has been able to provide emergency funds to students affected by the pandemic and recent hurricanes, increase scholarship offerings, further develop program opportunities, and name several of their colleges and schools.



Due to this successful partnership, Christ Church Cranbrook was able to celebrate the completion of construction in September 2022. The new space has been a blessing to all who have entered the campus.

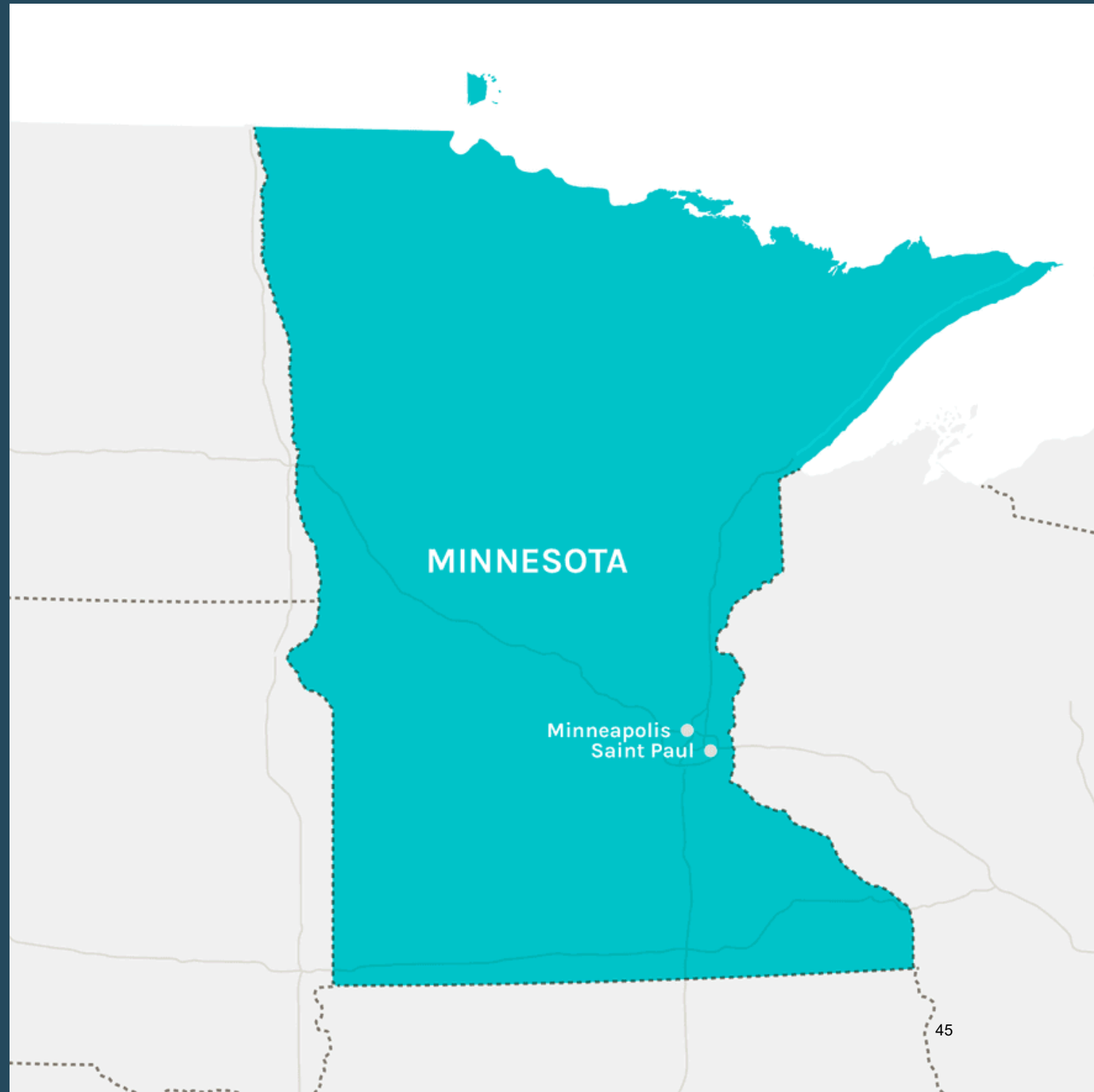

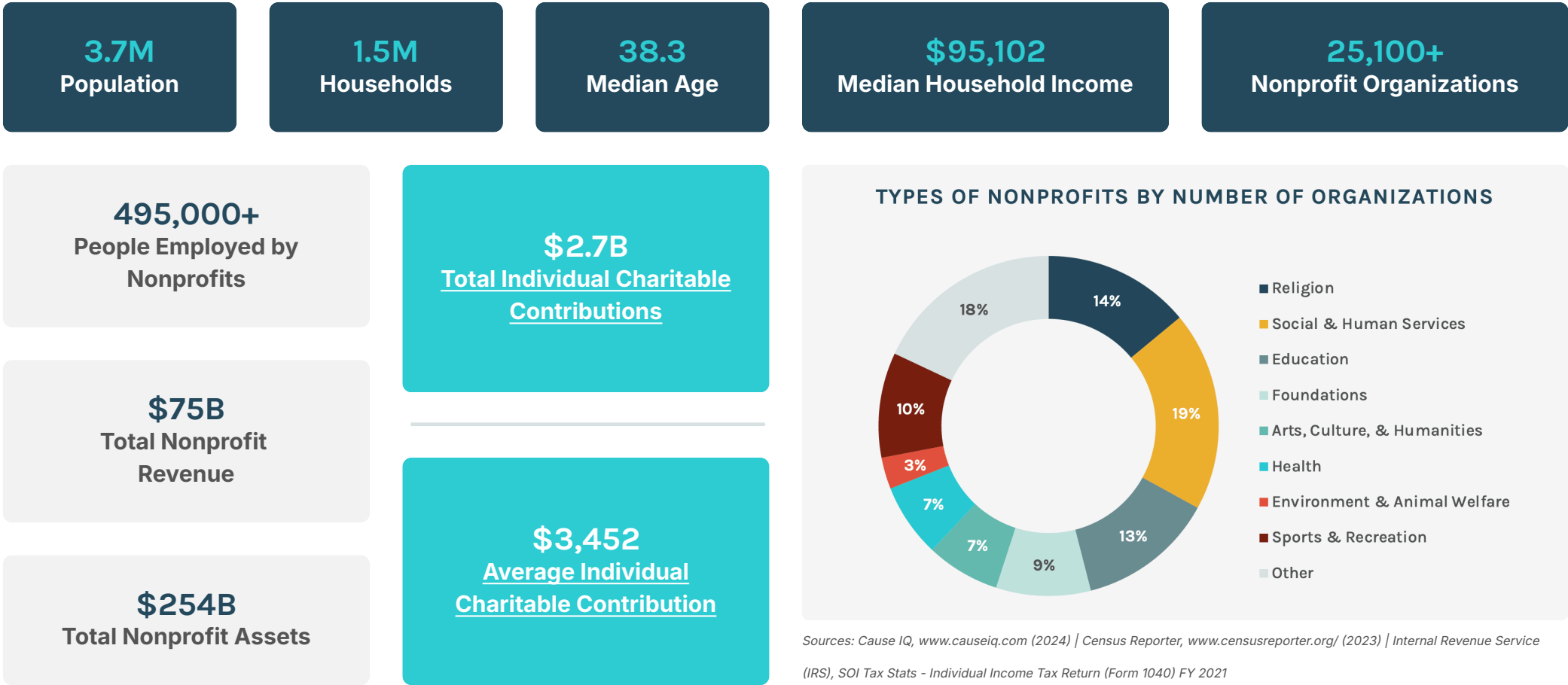

Case Study: National Marrow Donor Program



Working closely with the National Marrow Donor Program (NMDP) Foundation team, CCS helped raise over \$30 million during the first two years of the \$100 million comprehensive campaign, with the second year occurring during the early months of the COVID-19 pandemic.

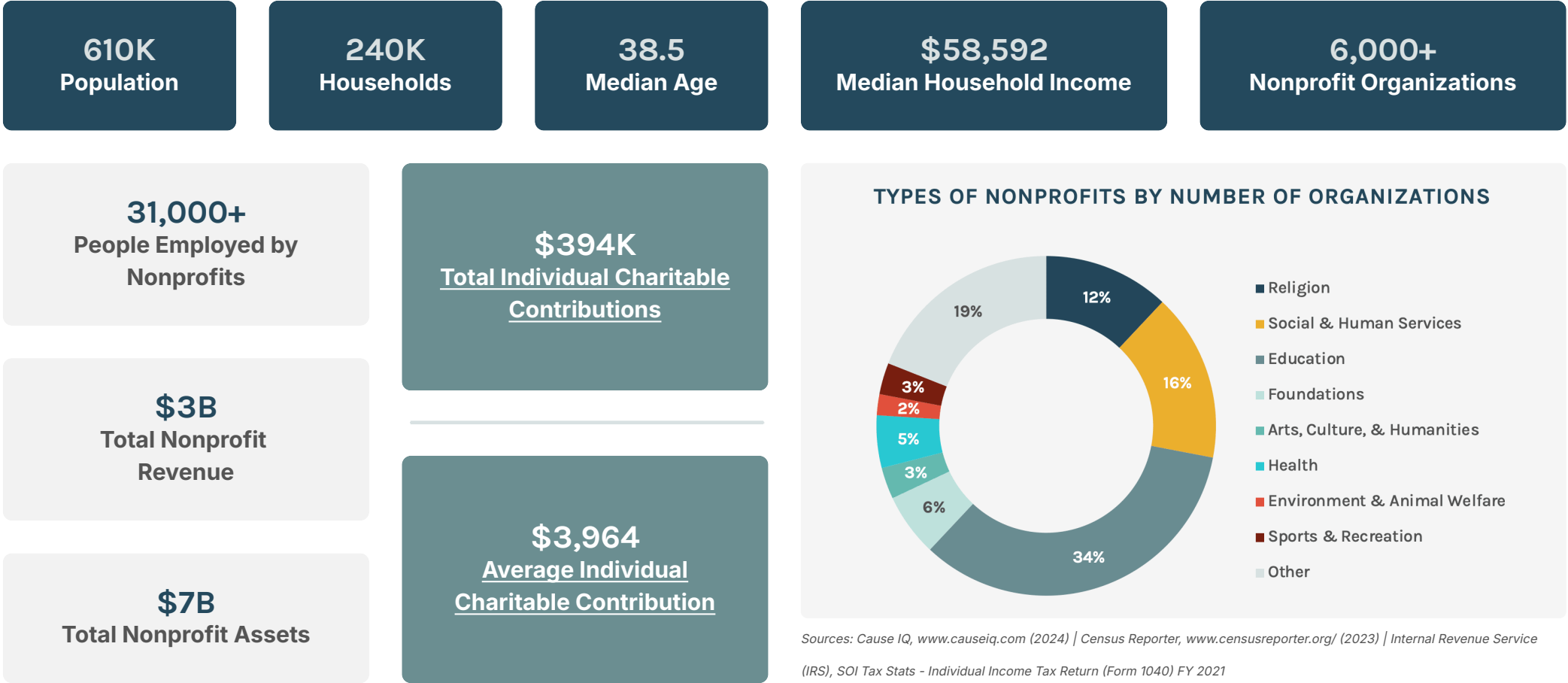

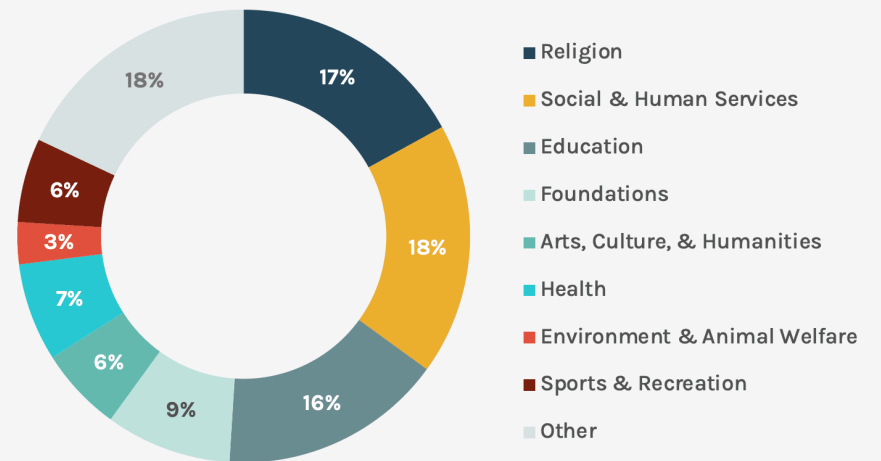

CCS conducted a resource assessment, evaluating the current volunteer and staff composition. Through strategic conversations with key stakeholders, community philanthropists, and development professionals, CCS helped design the leadership structure for the next campaign phase.

Using comprehensive data analytics and a prospect landscaping exercise, CCS identified philanthropic opportunities and created a Philanthropic Influencers list of 1,167 individuals and entities. This focused Forest Park Forever's prospecting and volunteer recruitment efforts.

Following the assessment, Forest Park Forever received major gifts, including \$20 million from Mr. and Mrs. James S. McDonnell III and \$30 million from Jack C. Taylor and Family, helping exceed its \$130 million goal. CCS is proud to partner with Forest Park Forever once again to support a transformational campaign.

CCS partnered with the Saint Louis Zoo to test case messaging, identify volunteer campaign leadership, create a top prospect list, identify new major gift prospects using predictive AI and wealth capacity, and right-size a fundraising goal. In addition, we partnered with the Zoo to augment the Development Department's organizational chart to optimize workflow and ensure the appropriate resourcing of staff in advance of a major fundraising campaign.

The Saint Louis Zoo is ready to commence fundraising for \$160 million with capital projects prioritized at WildCare Park and the Saint Louis Zoo, along with \$20 million for the endowment. A comprehensive planning phase will allow for the recruitment of volunteers, campaign material development, and top prospect engagement. Projects will provide interactive experiences for children and families to learn about animals as well as create spaces dedicated to conservation breeding of some of the world's most endangered species.

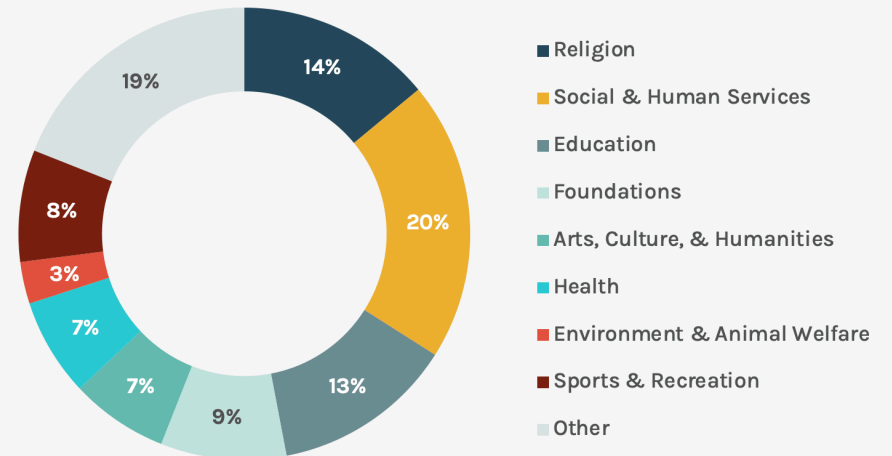

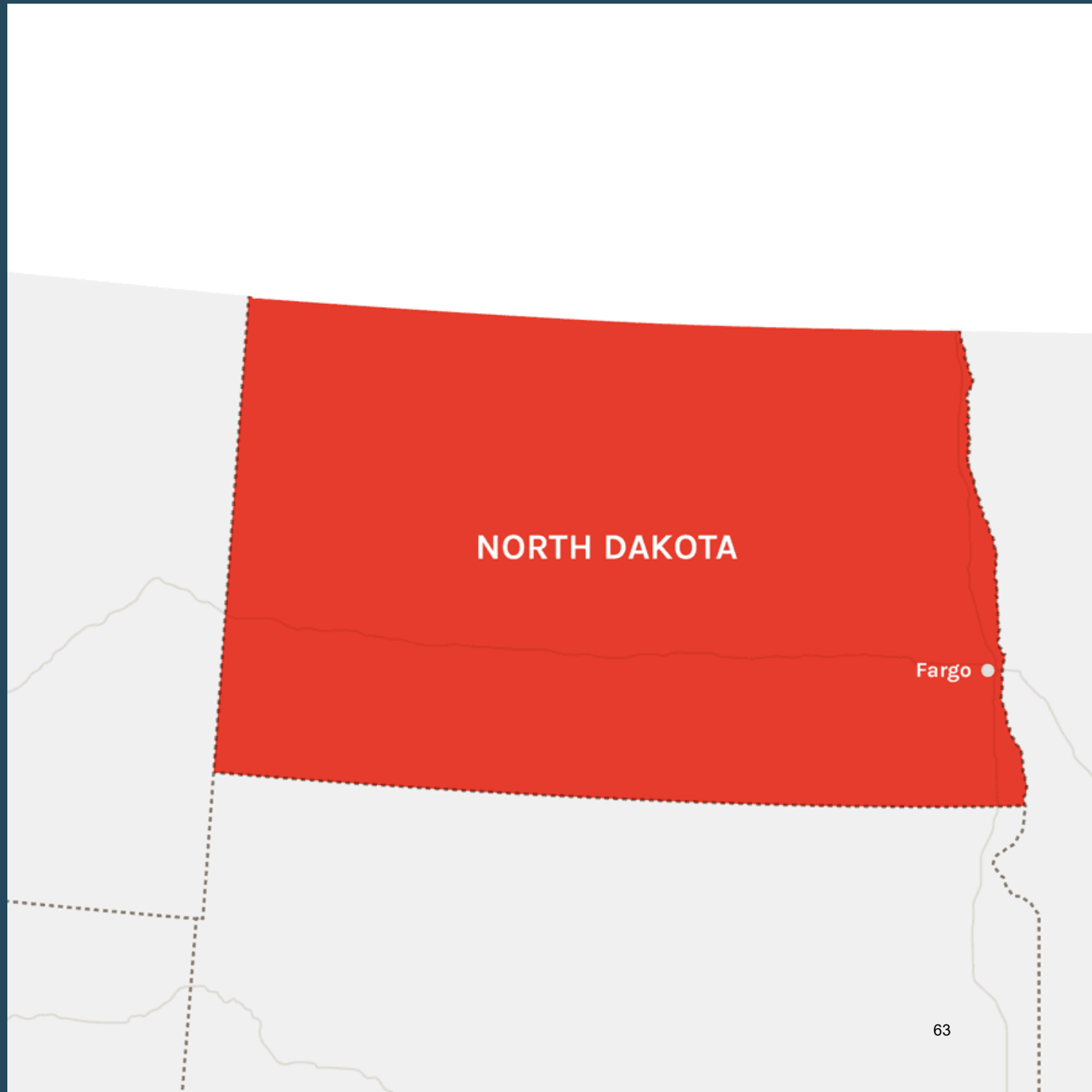
TYPES OF NONPROFITS BY NUMBER OF ORGANIZATIONS

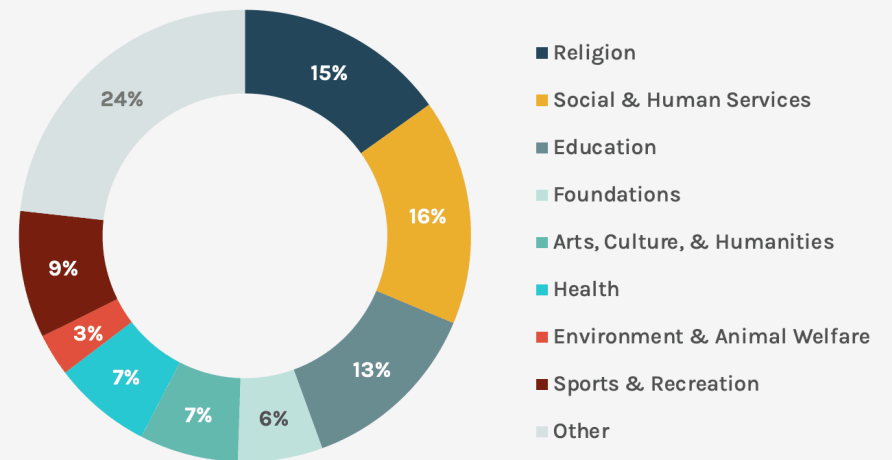

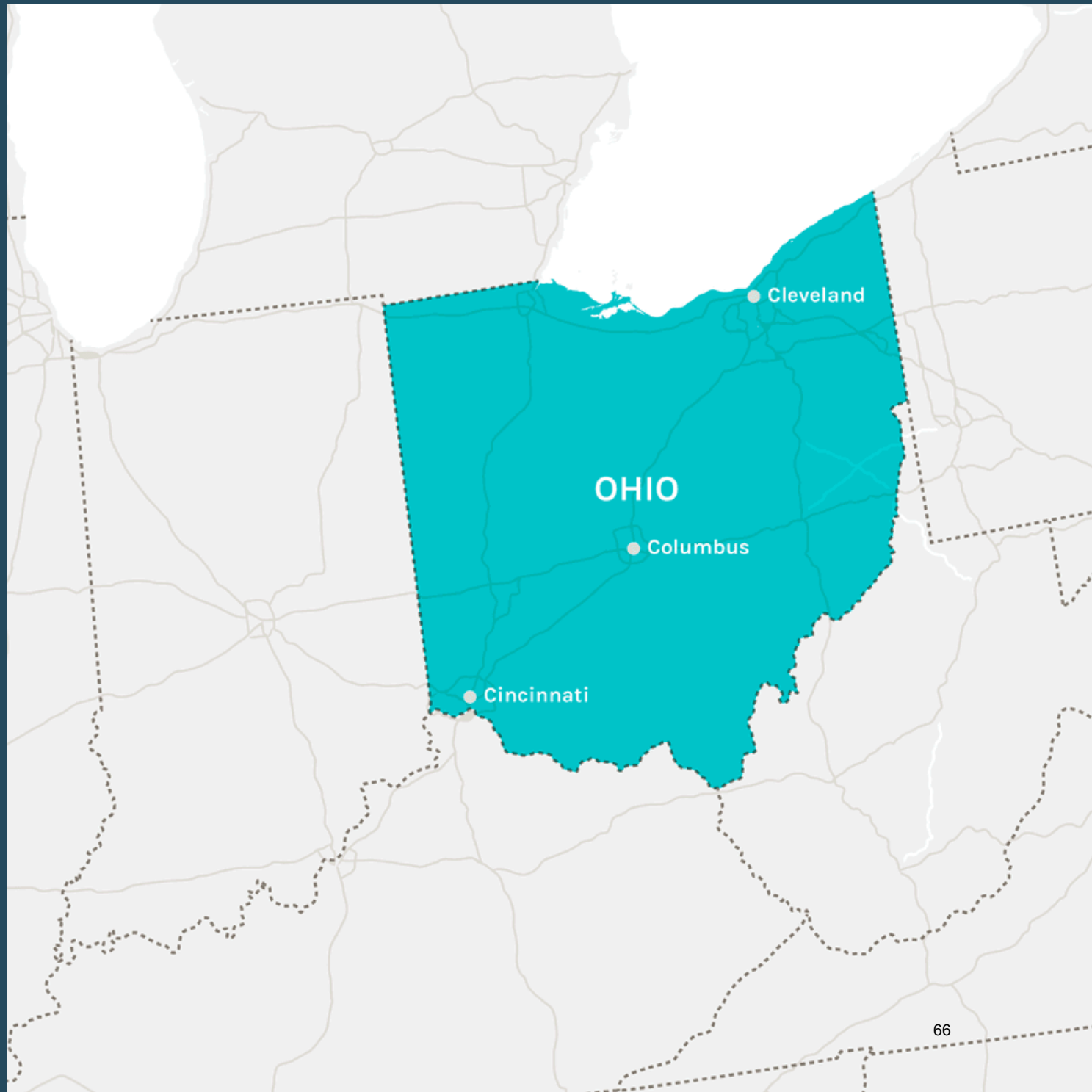

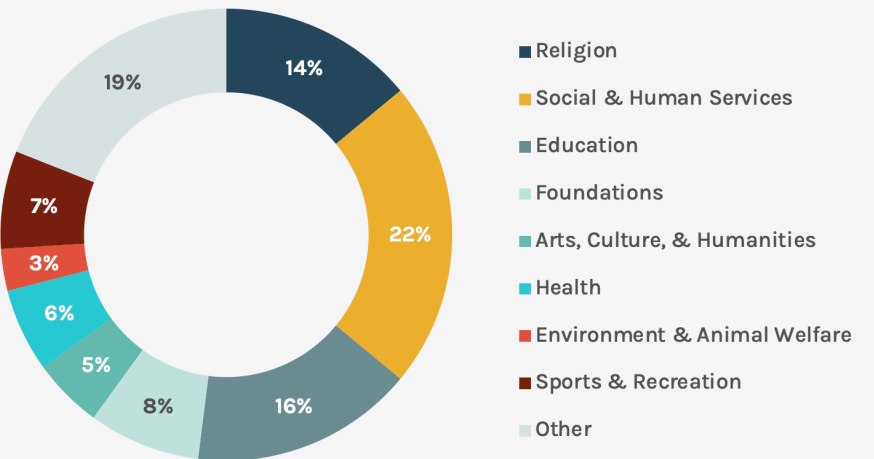

CCS partnered with Nationwide Children's Hospital to develop fundraising resources with the intent of sustainably doubling annual philanthropic revenue, and design and launch a formal campaign to support the Hospital's strategic plan. CCS performed a development assessment of historical fundraising performance, conducted a campaign planning study, and ultimately helped design and launch the *Be the Reason* campaign.

The *Be the Reason* campaign was a resounding success, closing one year ahead of schedule and well over its initial fundraising target. Notably, in 2016, Nationwide Children's Hospital announced a transformational \$50 million gift from Big Lots in support of the Big Lots Behavioral Health Pavilion, America's largest pediatric behavioral health treatment and research center. Since completion of the campaign, the Foundation's original objective of sustainably doubling pre-campaign annual fundraising revenue has been achieved.

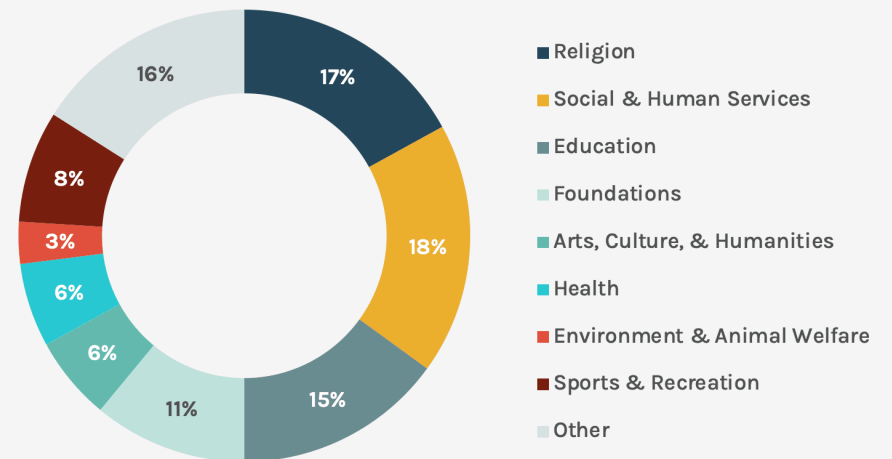

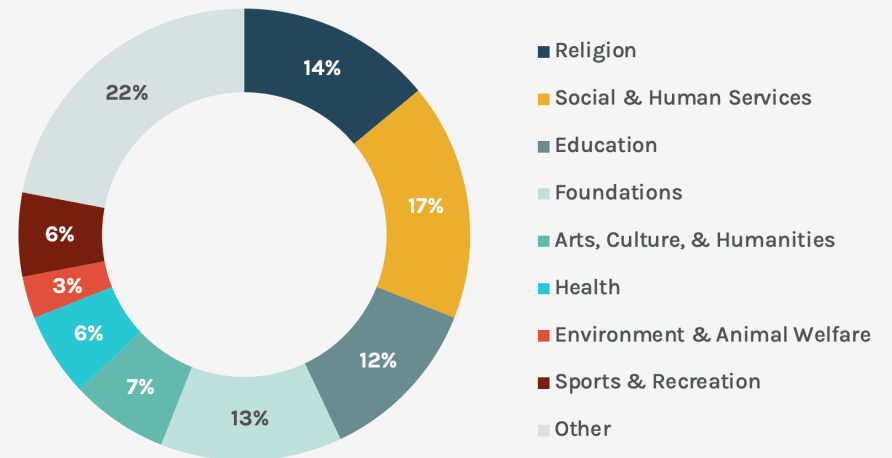

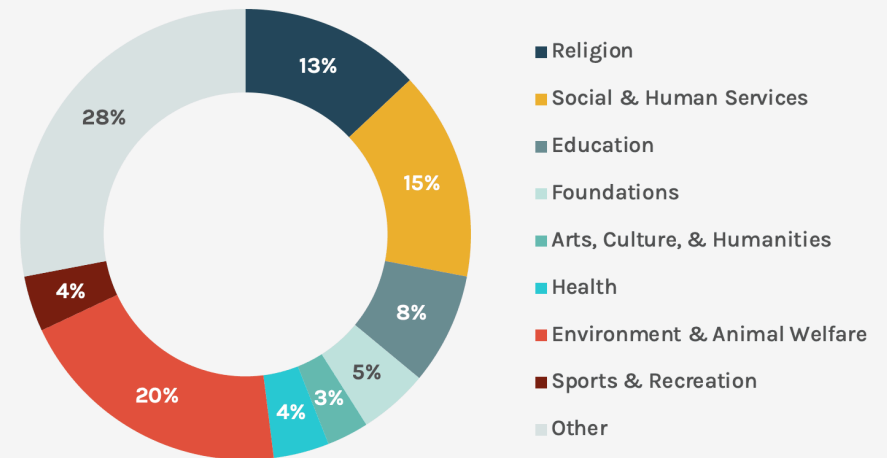

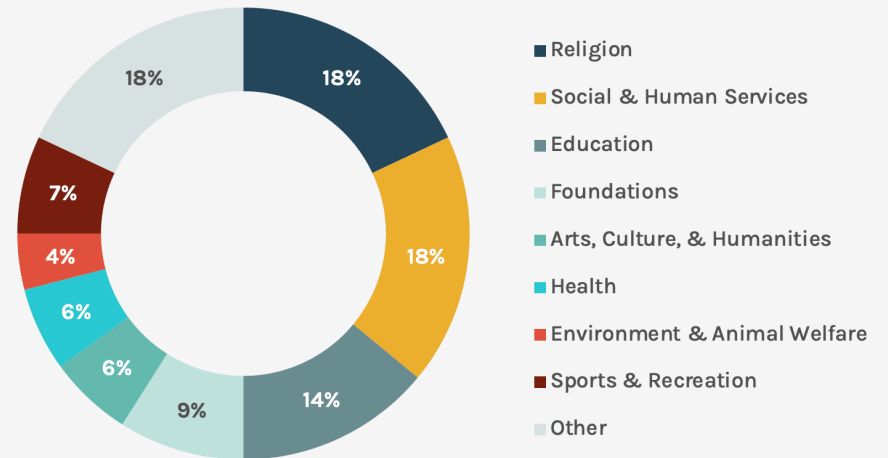

CCS first partnered with the Nashville Symphony in the early 2000s to raise more than \$123.5 million to support the orchestra's rise to national prominence, expand its music education programs, and open the Schermerhorn Symphony Center.

Schermerhorn Symphony Center, the orchestra's home since 2006, is a distinctive neo-Classical building with architectural elements that pay homage to the history, culture, and people of Middle Tennessee and is today considered one of the world's finest acoustical venues.

CCS later assisted Nashville Symphony by managing their endowment campaign, *Sustaining Greatness*. The campaign focused on restoring the Schermerhorn Symphony Center after flooding in May 2010 while fortifying resources available for artistic initiatives, music education, and community engagement programs. More than \$22 million was raised.

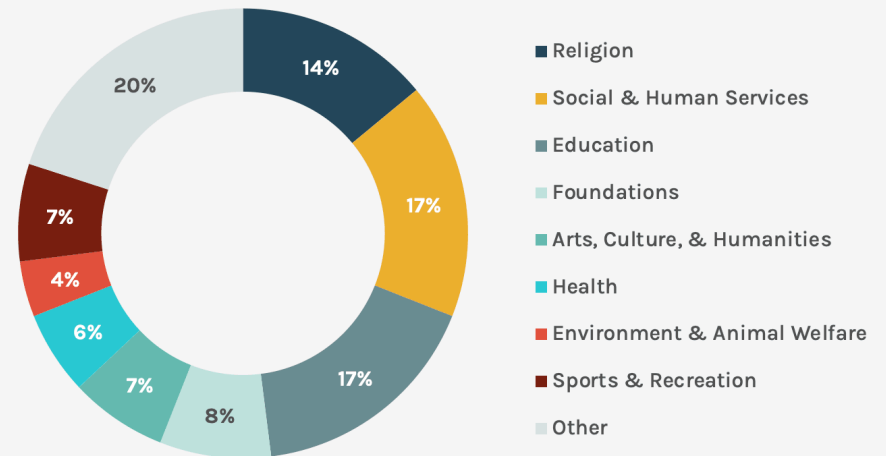

CCS has been privileged to partner with the Diocese of Austin on two extraordinary fundraising initiatives, most recently the *Encountering Christ* campaign, which concluded successfully in 2020.

With Bishop Vásquez's leadership, the *Encountering Christ* campaign has to date raised more than \$102 million on its \$85 million goal with the recent completion of Christ the King in Belton, Texas. The campaign showed notable success from the start, receiving pledges of \$20 million during the first six months of the 30-month timeline and garnering the two largest gifts in the Diocese of Austin's 70-plus-year history.

Funds from the *Encountering Christ* campaign will provide for local parish needs; bolster ministries, Catholic education, and faith formation; support clergy; and enhance growth and development across the Diocese of Austin.

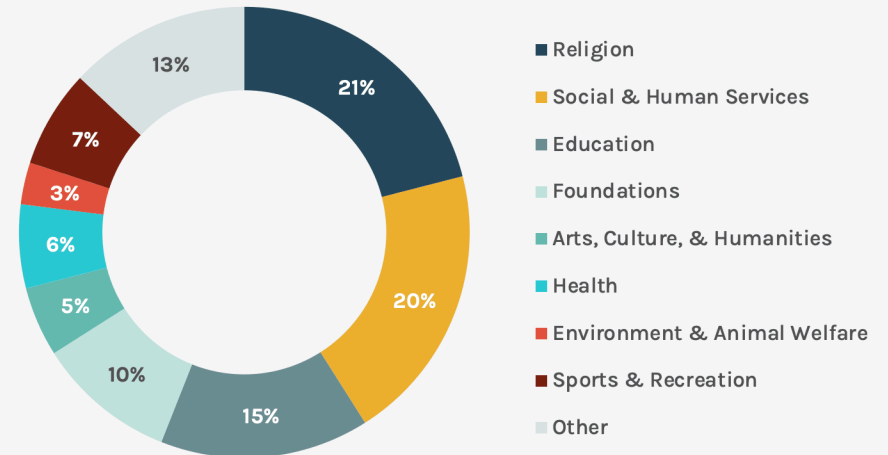

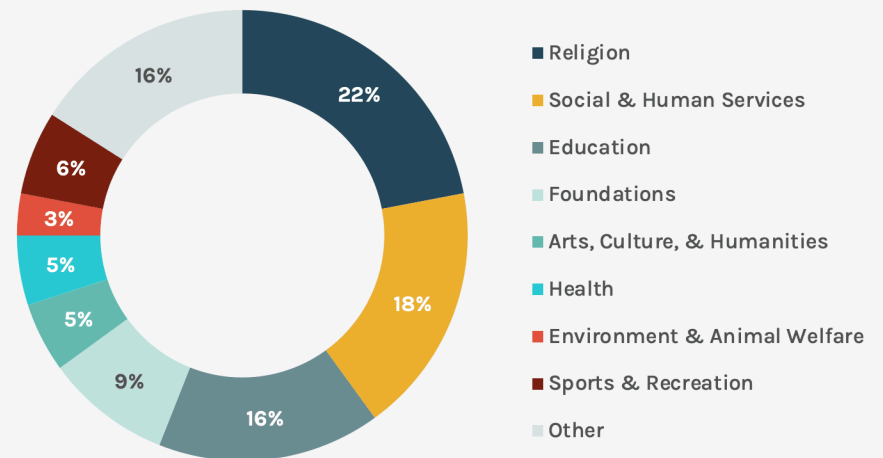

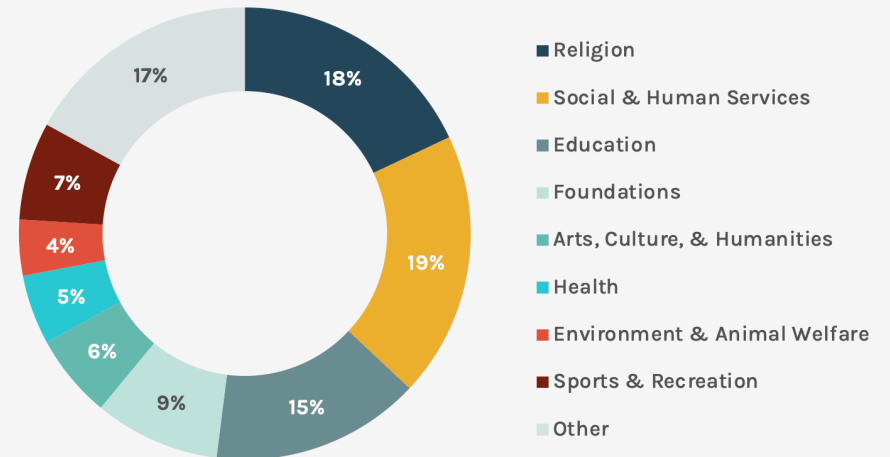

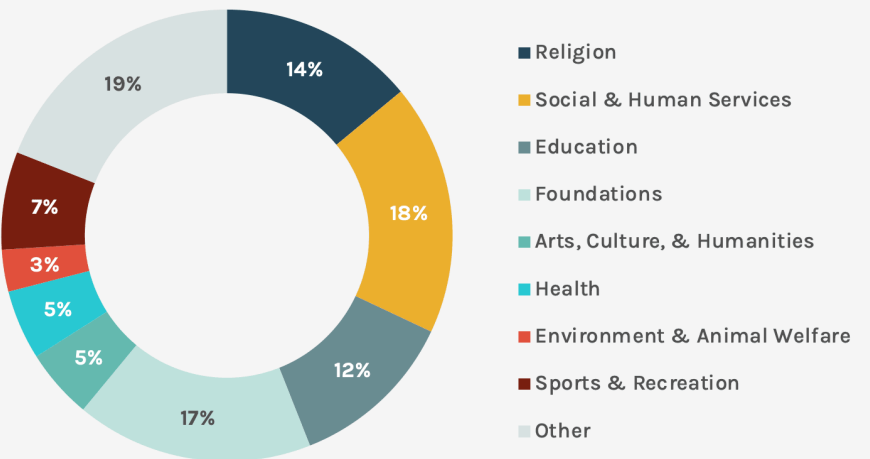

Case Study: Medical College of Wisconsin and Froedtert Hospital

CCS partnered with Medical College of Wisconsin (MCW) and Froedtert Hospital from 2015 to 2020 in support of their comprehensive campaign. After completing a feasibility study in the first year of our engagement, CCS began full-time, on-site campaign direction to raise \$200 million by the end of 2020. CCS worked shoulder to shoulder with leadership at both institutions throughout the campaign, helping advance a data-driven approach, partner on major gift strategy and training, launch the public phase, and look beyond the near term to build relationships and implement best practices for the future.

In October 2019, the campaign launched its public phase with an elevated goal of \$225 million. At the end of the *Hope to Health* campaign in December 2020, MCW and Froedtert Hospital had raised over \$300 million—a 50% increase over the original goal. The campaign included a historic \$37.9 million gift to create the Kern Institute for the Transformation of Medical Education. This was the largest gift to MCW to date and the largest philanthropic gift in the state of Wisconsin in 2017.
